DELEGATION
BDO 2023 Financial Audit

Angela Spencer of BDO Canada LLP provided Council with the substantial 2023 Financial Audit report and Financial Statements for review and approval. The audit found no significant deficiencies to report, and all accounting processes were found to be in line with Canadian standards. Spencer spoke to the new standard required for asset retirement obligations, as well as the increase to assets which were mainly attributed to taking ownership of the Municipal Services Building and investment income. Administration asked Spencer to clarify the \$1.1M surplus which show as a cash surplus. Spencer explained that the surplus was mainly due to outstanding 2022 receivables showing in cash balances and was not an actual cash surplus. Council asked for further information about investment accounts and investment rebalancing.

Randy & Janice Carlson
Development Permit

Randy and Janice Carlson addressed Council regarding a revoked development permit for the development of a house on Lot 1138, Plan 2014-0085. The Carlsons shared information about the proposed development, a timeline of events since the permit was issued, costs associated with the work that had been completed prior to the development permit being revoked, information about allowances for Airport zoned properties in BC, and a letter of support from the business owners operating the adjacent floatplane base along with a breakdown of their working relationship with the Carlsons. The Carlsons believe that a house is an allowable principal use as accommodation for flight and maintenance crews and that the problem lies with Administration's differing interpretation of the "accommodation" definition. The Carlsons asked that Mayor and Council consider the reinstatement of the development permit, or they will request that the matter go to a Variance Board for further consideration. Councillor Slager voiced multiple concerns with the information provided to Council, which led to further discussion and questions. Council thanked the Carlsons for their presentation and advised that a response would be sent within two weeks' time.

Community Lottery Fund
