PUBLIC HEARINGS Zoning Amendment Bylaw 2024-03 KM 1023.5 Alaska Highway, Watson Lake

Deputy Mayor Hanchar stated the reason for the Public Hearing, being for the rezoning of the property listed as KM 1023.5 Alaska Highway, Watson Lake, from Rural Residential (RR) to Industrial (M2). Administration explained that there was public confusion about the property location listed on the Public Hearing ad because the Town listed the property address found on Title, which differs from actual Alaska Highway KM markers.

CAO Lockwood provided the following updates to Council:

- Supervisor training took place earlier in the week with a focus on administrative duties such as report writing and performance evaluations.
- Administration has been working on contract documents for upcoming procurements for capital budget purchases.
- CAO reports will move to a written format at the Committee of the Whole Meeting of March 5, 2024.

Q4 Department Reports

Council was in receipt of the 2023 Department Reports for the fourth quarter. Council commended Town staff for well written concise reports and noted the progress made in this area. Councillor Slager expressed concern with a governor being set in the new fire trucks, which Administration explained is still being discussed with YG and RCMP and yet to be decided. Administration also addressed Councillor Burdes' question about why the Parks

and Rec Department Report not provided; Administration will send the report to Council once available.

BYLAWS

Feeding of Wild Birds and Animals Bylaw 2024-02

The amended Draft Feeding of Wild Birds and Animals Bylaw was before Council for review. Council expressed satisfaction with the draft bylaw amendments and Administration's recommendation to have legal review it to ensure it is enforceable, prior to it being introduced for Second Reading.

> Fees and Charges Bylaw Bylaw 2022-08

Council was in receipt of an Administrative Report asking for an annual review of Fees and Charges Bylaw 202-08 to address fees currently missing from Schedule "A" and to consider recommended changes. Council asked that a draft bylaw be introduced for First Reading and discussion at the February 20, 2024 Council meeting.

COUNCILLOR OPEN FORUM

There were no questions or comments from Council.

GALLERY OPEN FORUM

M. Palmer:

- Expressed concern with the draft Feeding of Wild Birds and Animals Bylaw, particularly the section that states that spilt bird seed must be cleaned up, as many songbirds will only feed off of the ground. Palmer does not believe that birdseed on the ground is a major attractant of other wildlife.
- P. Carson:
 - Expressed concern with the Feeding of Wild Birds and Animals Bylaw. Carson explained how intelligent ravens are and the unique relationship that they have with humans, and believes that due to this, ravens should not be considered 'wild' animals. Carson does not believe that it is in the Town's best interest to monitor the feeding of wild birds and expressed concern with the potential fines and enforcement. Carson proposed a solution to create a sanctuary where bird enthusiasts and tourists could view and feed ravens to reduce nuisance situations within the municipality.
- P. McLeod:
 - Asked if the Town knew why there were red crosses spray painted in the snow around the community. One potential explanation provided was that it could be ATCO mapping out transformers.
