Council sought clarification several payables including those to Watson Lake Foods, Bee Jay's Towing, and Industrial Alliance and Financial Services Inc. Councillor Paquette asked why there were multiple cheque re-issued, which Administration explained was to replace stale-dated cheques issued in 2024.

REPORTS

RFT 2024-03 Supply and Delivery Of Two Fire Apparatuses

Council was in receipt of an Admin Report which included background information and contract award recommendations for RFT 2024-03 for the supply and delivery of two fire apparatuses for the Watson Lake Fire Department. One bid was received by Acres Industries in the amount of \$2,031,226.60; over budget by \$351,226.60. Council discussed the need for new fire apparatuses due to the department's current apparatuses age, condition, and NFPA standards. Administration also noted that the Town currently uses a YG Pumper apparatus to compliment its fleet, however this apparatus is on lease and the current MOU has expired.

Administration recommended that Council accept the bid from Acres Industries for the purchase of two apparatuses through Gas Tax Funding. Administration expressed concern with waiting and re-tendering the apparatuses in 6-12 months in fear that costs will continue to rise.

**NEW & UNFINISHED
AYC Resolutions**

Mayor Hanchar proposed four resolutions in principle, to go before AYC for consideration:

Resolution #1 – RCMP Staffing in Rural Yukon. The purpose of the resolution is to help address RCMP detachment staffing challenges in communities by proposing that the Department of Justice allows suitable community postings to be extended if there is support from municipal and first nation governments, and the community.

Resolution #2 – On-demand Energy Charges to Yukon Communities. The purpose of the resolution is to propose that the Yukon Utilities Board re-assess and potentially remove on-demand energy charges that are charged to municipalities to off-set other shortfalls.

Resolution #3 – Sharing of Information for Prolific and High-Risk Offenders. The purpose of the resolution is to propose that Yukon government legislation be amended to allow for the sharing of information between agencies to allow for case

managements planning and to provide holistic approaches when dealing with high-risk offenders within the justice system.

Resolution #4 – Yukon Government *Animal Protection and Control Act*. The purpose of the resolution is to urge the Yukon government to create procedures and processes and to staff the positions that are required under the Act.

Council discussed the four resolution proposals in detail and provided support, in principle, for Mayor Hanchar to bring the resolutions forward for consideration by the AYC Board.

Council approve the four AYC resolutions in principle to be brought forward to the AYC Board of Directors for further consideration.

COUNCILLOR OPEN FORUM

Councillor Paquette:

- Asked if there was an update on the Housing First project and who will be managing the program once construction is complete. Administration has reached out for an update, but no response has been received to date. Administration also provided an update on the Frances Avenue subdivision development and explained that pressure has been applied to the Yukon government to get the lots available for sale.

Councillor Puckett:

- Asked if the Housing Accelerator Fund grants could be stacked with other funding.

Mayor Hanchar:

- Will be attending the FCM spring board meetings in Quebec next week on behalf of AYC.
- Advised Council of the quarterly AYC board meeting that Mayor Hanchar and Councillor Paquette attended. Topics of discussion included the territorial election, advocacy points and the impact of tariffs on municipalities. There were also presentations from Minister Mostyn, other party leaders and the Yukon Employee's Union.

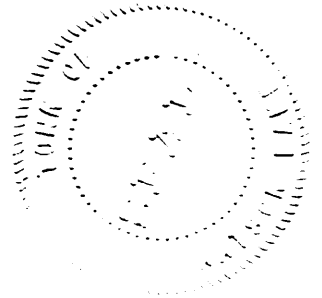
