

TOWN OF WATSON LAKE
BYLAW 2026-03

A BYLAW TO PROVIDE FOR COMMUNITY SERVICES GRANTS TO
LOCAL NON-PROFIT, RELIGIOUS AND CHARITABLE ORGANIZATIONS

WHEREAS section 245 of the *Municipal Act*, provides that a Council may by bylaw provide grants to any person, institution, association, group, government, or other body; and

WHEREAS Council adopted a policy to provide grants with respect to municipal taxes to eligible Watson Lake non-profit, religious, recreational and charitable organizations; and

WHEREAS Council has deemed it appropriate to provide grants to local non-profit organizations for 2026 Municipal property taxes;

NOW THEREFORE the Council of Municipality of Watson Lake in open meeting duly assembled, hereby ENACTS AS FOLLOWS:

The Town of Watson Lake will provide grants to be applied toward Municipal property taxes to the following non-profit organizations, in accordance with the Town of Watson Lake Community Services Grant Policy #20-17-147;

1. Watson Lake Outdoor Recreation Association shall receive a grant in the amount of \$1,482.39 to be applied to their 2026 Municipal Tax Account, being roll #910002070
2. Help and Hope for Families Society shall receive a grant in the amount of \$10,573.81 to be applied to their 2026 Municipal Tax Account, being roll #051008040
3. Watson Lake Ski Club shall receive a grant in the amount of \$903.64 to be applied to their 2026 Municipal Tax Account, being roll #900003070
4. Watson Lake Riding Association shall receive a grant in the amount of \$5,398.20 to be applied to their 2026 Municipal Tax Account, being roll #920164000
5. Signpost Seniors Association/Watson Lake Daycare shall receive a grant in the amount of \$6,155.61 to be applied to their 2026 Municipal Tax Account, being roll #004009020
6. Liard Aboriginal Women's Society shall receive a grant in the amount of \$595.49 to be applied to their 2026 Municipal Tax Account, being roll #901139020

7. Liard Aboriginal Women's Society shall receive a grant in the amount of \$3,302.60 to be applied to their 2026 Municipal Tax Account, being roll #601059040
8. Liard Aboriginal Women's Society shall receive a grant in the amount of \$538.32 to be applied to their 2026 Municipal Tax Account, being roll # 021024070

This Bylaw shall come into full force and effect upon the final passing thereof.
