

TOWN OF WATSON LAKE

BY-LAW 90-08

Being a By-Law to Provide for a Grant to Senior Citizens.

WHEREAS pursuant to the provisions of Section 220 of the Municipal Act, being Chapter 119 of the Revised Statutes of the Yukon 1986 and amendments thereto, provides that Council may, by By-Law, make grants to any person or association of persons;

WHEREAS Council have deemed it beneficial to provide a grant to senior citizens who are identified as having property ownership in Watson Lake; and

WHEREAS the grant is designed to assist in reducing the balance of the municipal portion of the year's taxes levied less the Yukon Government's Senior Citizens' Assistance Home Owners' Grant:

NOW THEREFORE, Council of the Town of Watson Lake in Open Meeting assembled ENACTS AS FOLLOWS:

- 1) The Town of Watson Lake will provide a grant not exceeding \$600.00 per applicant identified as a Senior Citizen for the purposes of this By-Law under Schedule "A".

Schedule "A" to this By-Law may be changed from time by motion of Council to reflect any change in the mill rate.

- 2) This By-Law shall come into full force and effect upon final passing thereof.
- 3) By-Law 47 is hereby repealed.
