

**TOWN OF WATSON LAKE**  
**BYLAW 2025-08**

A bylaw to provide and clarify powers of investigation and enforcement for employees of the  
Town charged with enforcing its bylaws

---

WHEREAS section 265 of the *Municipal Act*, R.S.Y. 2002, c, 154, as amended, (the “Municipal Act”), provides that Council may pass bylaws for municipal purposes respecting the enforcement of bylaws; and,

WHEREAS section 338 of the Municipal Act provides that a municipality may enforce its bylaws and other Acts under which the municipality or its officers are given powers of enforcement; and,

WHEREAS section 339 of the Municipal Act provides that Council may, by bylaw, provide for the appointment of enforcement officers for the enforcement of bylaws and other Acts under which the municipality or its officers are given powers of enforcement, and may define their duties and responsibilities;

NOW THEREFORE the Council of the municipality of the Town of Watson Lake ENACTS AS FOLLOWS:

**1.0 SHORT TITLE**

This bylaw may be cited as the “Bylaw Enforcement Bylaw.”

**2.0 DEFINITIONS**

In this bylaw,

“ENFORCEMENT OFFICER” means an employee of the Town appointed as an Enforcement Officer pursuant to the *Municipal Act*

"TOWN" means the municipal corporation of the Town of Watson Lake

"COUNCIL" means the elected Council of the Town of Watson Lake

**3.0 APPOINTMENT OF AN ENFORCEMENT OFFICER**

3.1 An Enforcement Officer shall be sworn as an enforcement officer within the meaning of the *Municipal Act*, for all purposes within the legislative competence of the Town.

3.2 An Enforcement Officer shall swear an oath as set out in Appendix "A" to this bylaw.

3.3 An Enforcement Officer shall have the power to enforce the provisions of bylaws enacted by the Council, and the provisions of other statutes as authorized by the Municipal Act.

#### **4.0 JURISDICTION**

4.1 The territorial jurisdiction of an Enforcement Officer shall extend throughout the municipal boundaries of the Town of Watson Lake.

#### **5.0 POWERS**

5.1 For greater certainty, an Enforcement Officer is a “peace officer” as defined by the Criminal Code of Canada, as amended from time to time.

5.2 An Enforcement Officer may enter upon any land or structure in the Town without warrant, except a dwelling house, if the Enforcement Officer has reasonable and probable grounds to believe that such entry is reasonably necessary for any of the following purposes:

- a. To prevent the continuation of an offence under any bylaw of the Town;
- b. To obtain particulars of ownership of anything involved in an offence committed under any bylaw of the Town;
- c. To determine the identity of any person or animal involved in an offence committed under any bylaw of the Town;
- d. To search for, seize, and/or preserve evidence of an offence committed under any bylaw of the Town; or,
- e. Any other law enforcement purpose relating to the enforcement of any bylaw of the Town.

5.3 Pursuant to the provisions of the *Criminal Code of Canada*, a justice may at any time issue a warrant authorizing an Enforcement Officer who is named in the warrant to apply the search and seizure provisions of the *Criminal Code of Canada* in respect of any violation of any bylaw of the Town, with any such modifications as the circumstances require.

5.4 For the purposes of ensuring compliance with any bylaw of the Town or to enforce the provisions of any bylaw, an Enforcement Officer may signal or otherwise direct a person operating a motor vehicle to stop, or move to a place and then stop, and the person shall immediately comply with the Enforcement Officer’s signal or direction and shall not proceed for the time that is reasonably necessary to enable the Enforcement Officer to conduct any lawful inquiries.

5.5 Every Enforcement Officer has the powers of a peace officer granted by the *Motor Vehicles Act* as amended from time to time, with such modifications as are

necessary while engaged in the lawful execution of their duties, including those powers described in sections of the *Motor Vehicles Act*:

- a. 36 - Production of license
  - b. 50 - Production of certificate of registration
  - c. 86 - Production of financial responsibility card
  - d. 106 - Stopping for peace officers
  - e. 114 - Forcible entry of vehicle
  - f. 130 - Maintenance of equipment
  - g. 133 - Radar detectors
  - h. 134 and 135 - Peace officer directing traffic
  - i. 136 - Driving/parking contrary to rules
  - j. 181 - Parking restrictions
  - k. 203 - Use vehicle without consent
  - l. 217 - Required equipment for cycles
  - m. 230 - Peace officer directing traffic
  - n. 232 - Request by peace officer for ID
- 5.6 An Enforcement Officer may seize any personal property they believe is related to the commission of an offence contrary to any Bylaw and impound it until:
- a. the completion of legal proceedings relating to such property; or,
  - b. 30 days have elapsed from the date of seizure if no such legal proceedings have commenced.

## **6.0 PROTECTION FROM PERSONAL LIABILITY**

- 6.1 An Enforcement Officer is not liable for any loss or damage caused by anything said or done or omitted to be done lawfully, in good faith in the performance or intended performance of their functions, duties, or powers under this bylaw.

## **7.0 GENERAL INTERPRETATIONS**

- 7.1 Nothing in this bylaw detracts from any other powers conferred on an Enforcement Officer:
- a. in any other bylaw of the Town;
  - b. in any other Act of the Yukon Legislative Assembly; or
  - c. or at common law.

## **8. OFFENCE**

- 8.1 Any person who violates any provision of this Bylaw or obstructs an Enforcement Officer in the performance of their duties is guilty of an offence and subject to a maximum fine of five hundred dollars (500.00) or 30 days imprisonment, unless a specific provision of any other Bylaw applies.

**9.0 COMING INTO FORCE**

This Bylaw shall come into full force and effect upon the final passing thereof.
