**Road Maintenance and Repair  
Reserve Fund Bylaw**

A draft Road Maintenance and Repair Reserve Fund Bylaw was before Council for discussion. The purpose of the reserve fund is to start setting aside funds for future road maintenance and repair needs, outside of regular O&M expenses. Council was prepared to complete First Reading of the draft bylaw, as presented.


